CORRESPONDENCE:

Letter dated January 23, 2019 from Abby R. Schwanger, Director of Community Health, Erie County Health Department discussing data collection for the 2019 Erie County Community Health Assessment. Health Assessment mailings will begin in early March for adult surveys, and April for youth surveys. The Erie County Health Department will host a partner meeting in the Erie County Health Department Conference Center on Wednesday, February 13, 2019 from 1:30 p.m. to 2:30 p.m.

BUILDING OFFICIAL/ZONING ADMINISTRATOR:

Building Official/Zoning Administrator, Robert Kurtz, reported for January the Zoning Department issued 5 zoning permits with a total fee collection of \$125.00; the Building Department issued 8 permits with a total fee collection of \$1,542.00 and total valuation of work being done at \$149,702.24. Mr. Kurtz gave an update on the snow parking ban. The Road Crew discussed the issue with the management at Redwood Apartments on Wine Street; whereas, the management notified all tenants advising them to not park in the street.

Mr. Kurtz discussed progress of the new maintenance building. Star Inc. had their electrician temporarily hook up the electric to the heaters so building could be heated, and they could finish their work which includes painting the steel and sealing the concrete floor. The earliest Ohio Edison can hook up electric will be the week of February 11th.

Mr. Kurtz attended the Ohio Township Association (OTA) Conference in Columbus. Mr. Kurtz discussed a class called, "Transitioning Your Volunteer Department to Combination or Career and Making it Work" since the Vermilion Township Fire Department is experiencing this transition. Mr. Kurtz assured the Board, Vermilion Township has done everything that was discussed. The two most important things highlighted were to take your time since it will take several years for a full transition and make sure you have chosen the right Fire Chief which Mr. Kurtz stated the township has done well with both.

Mr. Kurtz discussed the letter, received by David Adkins, Ag Inspection Manager for The Ohio Department of Agriculture, addressing a program offered to property owners and/or local governments with regards to controlling the growing populations of Gypsy Moth. The ODA received application from local residents in the area requesting an aerial treatment to control a growing population of Gypsy Moth. The ODA, after analysis, concluded that a treatment is needed. The ODA, with the USDA, Forest Service, will be conducting a Gypsy Moth Suppression Treatment Project in the target area of Mason Road. Aerial treatment(s) of forested area infested with Gypsy Moth pest will begin in early to mid-May while the pest is in its early caterpillar stages. The plane will fly 50 feet to 100 feet above tree tops to put the first application down and the second application will take place approximately 5 to 7 days after the first application. Even though research shows the products used are not considered harmful to humans or pets, residents with concerns may want to remain indoors during the treatments, but there is no requirement to do so. Information about the Gypsy Moth and the ODA Gypsy Moth Management Program is available on their website www.agri.ohio.gov, click on "Safeguarding Animals & Plants, then click on "Plant Health", and then click on "Gypsy Moth Program". An Open House has been scheduled for the public on Thursday, February 21, 2019, at the St. Matthews Evangelical Lutheran Church, 15617 Mason Rd., Vermilion, OH, from 6:00 pm to 8:00 pm. Notifications will be sent to all residents in the target area.
