BUILDING OFFICIAL/ZONING ADMINISTRATOR:

Building Official/Zoning Administrator, Robert Kurtz, stated a reminder that the Ohio Department of Agriculture will be holding the Gypsy Moth meeting for the public on Thursday, February 21, 2019, at the St. Matthews Evangelical Lutheran Church, 15617 Mason Road in Vermilion from 6:00 p.m. to 8:00 p.m.

Mr. Kurtz gave an update on the new building. Ohio Edison informed the township that the new maintenance building is the next project on their schedule. The issue is the transformer replacement which can only be completed in dry weather. Weather permitting, the project should be completed either Thursday or Friday of this week.

VERMILION TOWNSHIP FIRE DEPARTMENT:

Assistant Chief Kurtz read Chief F. Triana's report in his absence: Fire Runs between 2/1/19 – 2/19/19. EMS – 29; MVC – 1; Smoke/odor – 2; Public Assist – 1; YTD: 100 Runs.

The Chief submitted a grant application to the State Fire Marshals, Division of Commerce. This is an individual department Equipment Grant Application. Maximum amount received if awarded would be \$15,000.00. Some of the items requested on the application are as follows: Helmets, Eye Shields, Protective Hoods, Bunker Coats & Pants, Fire Boots, Gloves, SCBA Facepieces and SCBA Air Cylinders. Total request is for \$43,490.00.

The Chief is working with Finley Fire technician to set a date to complete work on 842 turn signals. The Chief will keep the Board posted.

OLD BUSINESS:

Mr. Kurtz inquired about the damaged mailbox policy asking if the Board had time to review and if there were any questions. Trustee Dickel stated the current procedure has always been to replace the mailbox with a regular metal mailbox and a post, if need be, if the snowplow hits the mailbox or they knock it down. If the mailbox is damaged due to the pressure of the snow coming from the plow, it's up to the resident to replace their mailbox. Trustee Trinter agreed that should be the policy. Trustee Decker agreed to have a written policy that could be followed. Mr. Kurtz also pointed out, in the policies reviewed, a mailbox that was struck will be replaced if it was properly installed according to post office requirements. He gave example if the mailbox was installed too close to the road it may be hit if it's overhanging in the roadway at no fault of the snowplow drivers.
